**LIMITED WARRANTY**

Materials and Workmanship Warranty – All Steel Structures, Inc. (TOiBOX) warrants its products to be free from defects in materials and workmanship for a period of one (1) year from the date the product is delivered to the Original Purchaser.

**WARRANTY EXCLUSIONS**

THE FOLLOWING ARE SPECIFICALLY EXCLUDED FROM THE LIMITED WARRANTY:

- 1) Incidental, cosmetic, or consequential damages.
- 2) Damage caused by handling, shipping, transit, processing, or storage.
- 3) Damage resulting from improper installation, misuse, neglect, accident, or use in violation of instructions furnished by All Steel Structures, Inc.
- 4) Damage resulting from act of God, falling objects, external forces, explosions, fire, war, riots, or other such similar or dissimilar occurrence beyond All Steel Structures, Inc. control.
- 5) Failure resulting from edge corrosion.
- 6) Equipment and parts which have been altered in any way whatsoever without written authorization from All Steel Structures, Inc.
- 7) All repairs and replacement parts not authorized by All Steel Structures, Inc.
- 8) Any labor costs incurred in removing or reinstalling All Steel Structures, Inc. parts or products.
- 9) Damage caused by abnormal atmospheric conditions including, but not limited to, hail, exposure to corrosive or harmful chemicals (whether solid, liquid, or gas), airborne contaminants, animal waste, exposure to salt water spray, decaying materials, wet absorptive materials, and internal contamination created by improper ventilation or improper housekeeping.

**WARRANTY LIMITATIONS**

“Original Purchaser” is the original person or entity who purchases All Steel Structures, Inc. products for their own use. The Original Purchaser’s sole and exclusive remedy for breach of warranty, at All Steel Structures, Inc. sole discretion, is expressly limited to: 1) return of goods and repayment of the purchase price, or 2) repair and replacement of nonconforming goods or parts as set forth herein. The maximum liability of All Steel Structures, Inc. in connection with this Limited Warranty shall not in any event exceed the original price paid for the product claimed to be defective or unsuitable.

Written approval by All Steel Structures, Inc. must be obtained prior to having any repairs made or parts replaced under the Limited Warranty. Unauthorized claims will not be paid by All Steel Structures, Inc.. Written or verbal commitments by salesmen, dealers, and distributors do not qualify. For shipments of products and components replaced or repaired under the Limited Warranty that are approved, in writing, in advance by All Steel Structures, Inc., All Steel Structures, Inc. shall bear the cost of the shipment of such products and components. Repairs and replacement parts authorized by Toibox shall be subject to the Limited Warranty for the remainder, if any, of the aforesaid one (1) year period.

To assure the protections provided by this warranty, the Original Purchaser must complete the All Steel Structures, Inc. Warranty Registration Card and return it to the Corporate Office of All

Steel Structures, Inc. within ten (10) days of receipt of the materials. If you do not have a registration card, it is the Original Purchaser's obligation to contact All Steel Structures, Inc. immediately for a duplicate copy.
